# Irish History #83

## Irish History #83 – Dev's Maneuvers during the Summer of 1921

Eamon de Valera's (Dev's) call for a truce before the start of formal Anglo-Irish peace negotiations was accepted by British Prime Minister David Lloyd George's government.

According to Tim Pat Coogan (author of *Michael Collins: The Man Who Made Ireland*), the July 9, 1921 truce included the following important terms. The British agreed they would not pursue "Irish officers, or men, or war material or military stores;" nor would they interfere "with movements of Irish persons, military or civil." Additionally, the British agreed to stop sending "troops, RIC (Royal Irish Constabulary) and auxiliary police and munitions" to Ireland. The Irish rebels agreed to stop "attacks on Crown forces and civilians," or interfere "with British Government or private property." Additionally, the rebels agreed to not make any "provocative display of force, armed or unarmed."

Of course, a halt in the fighting was the key part of the truce. Significantly, the IRA did not have to surrender their weapons or stop drilling and training, while the British agreed to free rebel prisoners.

For de Valera, Irish self-determination was an overriding goal. He told the Gaelic American newspaper he could accept a limited form of Dominion status for Ireland if the Irish were given "control of their whole destinies." He indicated he could even accept "autonomy" for Ulster if they voted for it. He made these comments for public consumption.

Historians note that obfuscation was a core part of de Valera's character. Nowhere in the article were the words - Irish Republic - mentioned. Yet that is what he sought when he met the British Minister in London a few days later. Lloyd George told de Valera a Republic "was impossible" to deliver because it was "inconsistent with the [British] Monarchy." Dominion status was the best and only British offer.

De Valera told Lloyd George this was unacceptable because rebels had taken an oath and were fighting for a Republic. Nevertheless, de Valera said he would discuss the offer with the Irish Dail in Dublin, if the Prime Minister refrained from making it public. When the talks recessed, Lloyd George gave de Valera a stern warning that if the peace negotiations broke down the war would resume with "a great [British] military concentration" taking place in Ireland to suppress the rebellion and restore order. He told de Valera that war "will rest on your shoulders and yours alone." De Valera retorted: "if you insist on attacking us it is you, not I, who will be responsible."

A month later, the British released rebel prisoners except for Sean MacEoin. It was Michael Collins, not de Valera, who called this a violation of the truce and declared the Dail would not meet without MacEoin's release. He was released

that evening. Collins wrote a speech in Irish that MacEoin delivered. The speech proposed de Valera be called the "President of the Irish Republic."

De Valera addressed the Dail as President of the Irish Republic, when it convened in August. He called the British offer of Dominion status unacceptable, and the Dail rejected it.

Lloyd George's rejoinder to the Dail vote made clear the nascent peace talks were in jeopardy. He had told de Valera previously that negotiations would not take place if, as de Valera asserted, Ireland claimed to be an "independent and sovereign State." He noted that de Valera had not made this a basis for talks at their original meeting, and he reminded de Valera that "[f]rom the very outset of our conversation I told you that we looked to Ireland to own allegiance to the Throne, and to make her future as a member of the British Commonwealth. . . we cannot alter it." De Valera's insistence on an independent Republic put Ireland in a precarious position.

De Valera made the next move. He wrote to the Prime Minister suggesting a conference be held without "any condition precedent." Lloyd George responded by issuing a "free invitation to a conference on October 11 with a view toward ascertaining: 'How the association of Ireland with the community of nations known as the British Empire may be best reconciled with Irish national aspirations.'" De Valera accepted the invitation, replying "our delegates will meet you in London on the date mentioned 'to explore every possibility of settlement by personal discussion.'" De Valera agreed understanding that the basis for the peace conference as set forth by Lloyd George meant Ireland would be part of the British Empire.

It had to be clear to de Valera that British "recognition of an Irish Republic" was a non-starter. Attempting to square this circle, de Valera's solution called for Ireland to be "externally associated" with Great Britain though not a member of the British Empire. For him, "External Association" was a bridge between Dominion status and a Republic. Under his proposal, Ireland would maintain its sovereignty while being "associated with Great Britain for external affairs." This would preserve Ireland's neutrality in wartime and avoid "the stigma in republican eyes of coming under the imperial yoke." The Dail Cabinet approved this proposal.

Convincing the British of the merits of external association would become the job of the "Irish Plenipotentiaries" (delegates) to the formal peace conference in London. To them, however, it was a vague concept with an unknown

final form. De Valera told Arthur Griffith, who he named Chair of the delegation, external association was his way of maneuvering out of “the straightjacket of the Republic,” even though a Republic had been promised to the Irish people. Griffith told him: “I know, and you know that I can’t bring back a Republic.”

A majority of the Cabinet wanted de Valera to be a member of the official delegation. But he successfully refused, as did Cabinet hard-liners Cathal Brugha and Austin Stack. At one point, referring to the plenipotentiaries, de Valera was overheard saying: “We must have scapegoats.” This was another sign that he knew the upcoming conference would not deliver what had been promised.

De Valera named Michael Collins as second in command of the delegation. Collins balked feeling he was “not enough of a politician,” and that a settlement was for politicians like de Valera not soldiers like himself. In the end, however, Collins relented. He viewed his situation as akin to “a soldier carrying out an unpalatable order.” But he had no illusions about what the responsibility entailed. He saw it for what it was, “a trap.”

Joining Griffith and Collins in the delegation were Cabinet member Robert Barton, attorneys E.J. Duggan and Gavin Duffy, and Erskine Childers as Secretary. They had the impossible task of convincing the British to compromise on the idea of an Irish Republic, which was something the British had flatly told de Valera they would not do.

The Cabinet and the Dail approved the plenipotentiaries

and their “credentials.” Their credentials read: delegates “from the elected Government of the Republic in Ireland to negotiate and conclude” with representatives of His Majesty “a treaty or treaties of association and accommodation between Ireland and the community of nations known as the British Commonwealth.” The delegation was also instructed they had a “free hand” in negotiations subject to reporting to the Dail and submitting the final draft treaty before signing it.

De Valera gave the delegates a memorandum on external association. He also instructed them, privately, not to make any final decisions on “a main question” without informing the Cabinet in Dublin and awaiting the reply. We will look at the peace negotiation process in future chapters.

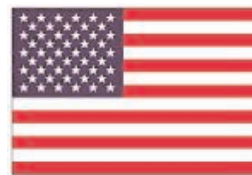
